Deadlines for Consortium Agreement and Documentation

Fall - October 1 Spring - March 1 Summer - July 1

This form should only be used by students taking coursework at a host school that is either a Private or non-Florida school. Students taking courses at one of the Florida SUS colleges or universities, state colleges or community colleges should go online to www.floridashines.org and complete the transient admissions application. Students who wish to receive financial aid at UNF while taking classes at another college or university during a specific semester must complete and submit this Consortium Agreement. However, Consortium Agreements need only be completed if the student enrolls less than full-time at UNF and is receiving Title IV funds. UNF is considered the "Home" institution and the other school is considered the "Host" institution. The courses taken at the Host school must be hours that are applicable toward the student's UNF program of study. The student should make every effort to take the courses at UNF before taking them at another school.

In addition to submitting this completed form to One-Stop Student Services, students seeking financial aid must also submit:

- **Concurrent/Transient Enrollment Form**—Prior to registering for courses at the host institution, this form must be completed by the student and signed by the student's academic advisor listing the approved course(s). The form must also be signed by One-Stop Student Services.
- Paid Fee Slip from Host institution—The fee slip must show that the student is enrolled in and has paid in full for the approved courses. The fee slip must list the courses and show a S0 balance.
