Subject: Collective Bargaining Agreement with the Coastal Florida Police Benevolent Association, Inc. (PBA)

Recommended Action:

Ratification of the 2024 Revisions to the UNF-PBA Collective Bargaining Agreement

Background Information:

The University is now in the second year of the three-year term of the current Collective Bargaining Agreement with the PBA. Each year, a small number of articles are revisited. This year, two articles were updated. PBA members have ratified these changes. Here is a summary of the changes:

Article 11 – Work Period / Overtime

- Added a 4% shift differential for in-unit officers who are assigned to the night shift.
- A one-time lump sum payment will be made to in-unit officers assigned to the night shift. This payment will account for the shift differential they would have earned from July 1, 2024 (the start of this contract cycle) to mid-October, when the new system will be in place to handle the payments going forward.

Article 18 – Uniforms and Equipment

• The maintenance amount has been increased from \$500 to \$1,000 for employees who have been furnished a uniform by the University, and from \$600 to \$1,100 for plain clothes positions.

Subject: 2023-2024 Annual Presidential Evaluation

Recommended Action:

The Board of Trustees will conduct an annual evaluation of President Moez Limayem.

Background Information:

Kevin Hyde, Chair of the UNF Board of Trustees (BOT), will lead the review of President Limayem's performance for the period from July 1, 2023, to June 30, 2024.

In accordance with Florida Board of Governors Regulation 1.001(5)(g), each board of trustees shall conduct an annual evaluation of the president. The chair of the board of trustees shall request input from the Chair of the Board of Governors, who may involve the Chancellor, during the annual evaluation process pertaining to responsiveness to the Board of Governors' strategic goals and priorities, and compliance with systemwide regulations.

President Limayem submitted his self-evaluation for the 2024 reporting year, which was sent to the Board on August 27, 2024. Following the Board of Governors regulation, the Chair discussed the president's performance with the Chair of the Board of Governors. The Chair then prepared an initial draft performance evaluation, which was shared with the trustees before the September 30 meeting.

Subject: Consideration of Incentive Compensation and Review of Compensation

Recommended Action:

Board of Trustees will review President Limayem's annual compensation and consider an incentive compensation award for the President, in accordance with the President Limayem's Employment Agreement.

Background Information:

The President shall be eligible for an annual award of incentive compensation upon completion of each contract year. The award of incentive compensation shall be considered in connection with the Board's annual evaluation of the President and shall be based on the Board's assessment of the President's achievement of mutually agreed upon performance measures and goals. The President is eligible for an annual award of incentive compensation not to exceed \$100,000.00. The award of incentive compensation, including the amount, is solely at the discretion of the Board. In addition, per Section 4.1 of President Limayem's Employment Agreement, the President's base salary can be adjusted annually.
