Background Information:

The University is in the final year of the three-year term of the current Collective Bargaining Agreement with the United Faculty of Florida. Each year, a small number of articles are revisited. This year, the parties have reached tentative agreement on five articles, in addition to the wage article you previously ratified: Article 4 (UFF Rights); Article 9 (Guidelines); Article 17 (Summer Appointments and Assignments); Article 18 (Performance Evaluations); and Article 28 (Conflict of Interest/Outside Activity). The membership of UFF is in the process of ratifying these articles. A representative of the UNF Board of Trustees bargaining team will address the Board to discuss the revised articles.
