

**Parking Advisory Council Meeting
December 2, 2005
10:00 a.m.
A&F Conference Room**

MINUTES

Members Present: Everett Malcolm (Chair), Jared Callahan (Vice Chair), Tammi Horn, Stephen Horne, Diane Tanner, Corey Trent, Mike Trotter, and John Yancey.

Members Absent: Dr. Judy Solano and Marco Urbano.

Others Present: John Dean (UPD) and Vince Smyth (Auxiliary Services).

The meeting was called to order at 10:05 p.m. by Chair Everett Malcolm.

1. Approval of Minutes

The minutes from the 11/18/05 meeting were approved with no corrections.

2. Types of Permit Categories for 2006-07

Everett Malcolm said that a couple of Council members may have to depart at 11:00 a.m. for class and/or meetings. Other members are not able to attend the meeting today. Therefore, he recommended that Council members study and discuss with their groups and then vote electronically by noon on Wednesday, December 7. The Parking Council agreed with Everett Malcolm's proposal.

The Parking Council discussed the proposed options and the following comments were made:

- Jared Callahan said he is in favor of increasing the parking fines to \$30 (a one-time increase) in 06-07 and not to \$50. This would make the fine the same as the City of Jacksonville.
- John Dean said that the cost of tickets in the city of Jacksonville varies depending on the type of violation.
- Diane Tanner polled her classes and the result was that they would rather have tickets go up than the price of permits. Tammi Horn asked students in her Department and got the same response.
- There was discussion on raising \$5.00 per year until it reaches \$50.00.
- There was also discussion on raising \$5.00 this year to \$30.00 to be reviewed next year by the Parking Council.
- Vince Smyth commented that if a \$5.00 increase is proposed beyond 06-07 that this should be thought carefully through.
- Everett Malcolm said that the temporary parking agreement on the North Lot has been signed. It is anticipated that the parking area will be available by the fall semester. This is for a five-year period and, in summer 2011 it will be reviewed.
- Everett Malcolm informed the Council that later this afternoon there is a meeting of a Committee to discuss a transportation access fee. If that is implemented, then this fee would be added to student fees.
- Corey Trent questioned why the costs for Housing permits should be raised. The Housing students are more involved in Campus life than commuters.

- Diane Tanner asked Vince Smyth to figure what taking 3% off Housing would do to the numbers. This resulted in a \$9,000 loss. There was discussion on who would make up the loss.
- There was discussion on moving Housing into the general parking.

Everett said that the three final options A (Faculty and Staff), B (New Plan) and C (Student Plan) of Parking Permit Pricing for 06-07 will be sent by e-mail to Council members. Votes should be submitted by e-mail no later than noon, Wednesday, December 7.

3. **Other Business** - There was no other business.
4. **Future Meetings** - to be determined.

The meeting was adjourned at 10:55 a.m.
