

NOTICE OF EMERGENCY REGULATION AMENDMENT

Schedule of Tuition and Fees

SUMMARY:

Florida Board of Governors Regulation 1.001 provides that each Board of Trustees is authorized to promulgate University regulations in accordance with the Regulation Development Procedure adopted by the Board of Governors. Such regulations must be consistent with the law and the regulations and strategic plan of the Board of Governors. The Legislature sets tuition for undergraduate students. The Board of Trustees are granted authority to set tuition levels for all other groups.

STATEMENT OF FACTS AND REASONS FOR EMERGENCY REGULATION:

The emergency regulation is necessary in order to timely implement rates and fees for the Fall 2012 registration period. An emergency regulation is necessary as the ability to collect such fees has been relied on in developing the University's budget. The ability to assess the tuition and fee amounts is vital to the fiscal welfare of the University and as such the University must proceed with the regulation authorizing such tuition and fees on an emergency basis. Pursuant to the Regulation Development Procedures, the emergency regulation is valid for ninety (90) days, thus a permanent regulation identical to the revisions herein will be promulgated.

I. OBJECTIVE & PURPOSE

The purpose of this regulation is to set forth current tuition and fee amounts per credit hour that students will be assessed during the Fall 201~~1~~² and Spring/Summer 201~~2~~³ terms.

II. STATEMENT OF REGULATION

(1) Tuition shall be defined as fees assessed to a student for enrollment in credit courses at the University of North Florida, in accordance with law, rules and policies of the Board of Governors and the University of North Florida Board of Trustees. Tuition consists of the following fees, depending on whether a student is a resident or a non-resident

(a) Resident tuition, comprised of the following, shall be defined as the fees charged an enrolled student who qualifies as a Florida resident as defined in applicable Florida laws and regulations:

1. Tuition;
2. Tuition Differential Fee¹;
3. Student Financial Aid Fee;
4. Capital Improvement Trust Fund Fee;
5. ~~Building Fee;~~

¹ Students in attendance at the University prior to July 1, 2007, and who maintain continuous enrollment, may not be charged the tuition differential fee. Beneficiaries having prepaid tuition contracts in the Prepaid College Tuition Program, in effect on July 1, 2007, are exempt from the payment of the tuition differential fee. The tuition differential fee is not covered by Bright Futures Scholarship Program.

(b) Out-of-State fees comprised of the following, shall be defined as the fees charged an enrolled student who does not qualify as a Florida resident as defined in applicable Florida laws and regulations:

- 1. Tuition;
- 2. Tuition Differential Fee²
- 3. Out-of-State Fee;
- 4. Student Financial Aid Fee;
- 5. Non-Resident Student Financial Aid Fee;
- 6. Capital Improvement Trust Fund Fee;
- ~~7.~~ ~~Building Fee;~~
- ~~87.~~ Health Fee (which includes the Clinic, Counseling, Wellness and Medical Compliance Fees);
- ~~98.~~ Athletic Fee;
- ~~109.~~ Activity and Service Fee;
- ~~110.~~ Transportation Access Fee;
- ~~121.~~ Technology Fee, and
- ~~1312.~~ Student Life and Services Fee.

(2) The following tuition shall be levied and collected effective for the Fall 201~~12~~ and Spring/Summer 201~~23~~ semesters for each student regularly enrolled, unless provided otherwise by law or in this chapter.

(c) Pursuant to Section 1009.285 F.S., each student enrolled in the same undergraduate course more than twice, shall be assessed an additional \$159.87 per credit hour charge in addition to the fees outlined above in paragraph (2)(a) for each course. [Students entering the University in 2012-2013 shall pay a fee equal to 100 percent of tuition for each credit hour in excess of 115%.](#)
